"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as a TEN (10) ACRE tract on plat of property of Charles B. Thomas made by Carolina Engineering & Surveying Co. dated April 1968 and revised February 24, 1969 and having the following metes and bounds according to said plat.
