NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Melbourn Lane and being known and designated as Lot No. 14 on plat of Wellington Green recorded in the RMC Office for Greenville County in Plat Book YY, Page 29, and having according to said plat, the following metes and bounds, to wit:

Beginning at an iron pin on the northern side of Melbourn Lane, joint front corner of Lots 13 and 14 and running thence with the common line of said lots N 30-23 E 166.0 feet to an iron pin; thence S 59-53 E 100.2 feet to an iron pin, joint rear corner of Lots 14 and 15; thence with the common line of said lots S 30-23 W 166.5 feet to an iron pin on the northern side of Melbourn Lane; thence along the northern side of said Lane N 59-37 W 100 feet to an iron pin, the point of beginning.
