NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, on the East side of Langley Road, containing 14.76 acres and having the following metes and bounds:

BEGINNING at a point in the center of Langley Road, in the line of property belonging to Carl Hart, and running thence along the center of said road, N. 33-30 E. 169 feet to bend in said road; thence still along the center of said road, N. 22 E. 400 feet to point; thence S. 81-20 E. 505.5 feet to pin at spring; thence S. 21-05 E. 818 feet to iron pin in center of Moore Road; thence along the center of said road, S. 22 W. 300 feet to corner of property of Cecil Byers; thence N. 57 W. 1112 feet to the Beginning corner.
