(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **FOUR THOUSAND AND NO/100THS**-----

DOLLARS (\$ 4,000.00), with interest thereon from date at the rate of **EIGHT (8%)** per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Saluda Township, a short distance South of S. C. Highway 11, and being a portion of the property of Mary Hagood Brown and David B. Brown as shown on plat made by Terry T. Dill, dated November 13, 1969, and having, according to said plat, the following metes and bounds, to-wit:

- BEGINNING at an iron pin in the center of a County road approximately 498 feet South of the center of S. C. Highway 11, prior to it's being widened in 1969, 1970, and running thence N 71-15 E 122 feet to an iron pin; thence S 32-32 E 191.5 feet to a point in the center of the Southern Bell Telephone right-of-way; thence S 83-15 W 183 feet to an iron pin in the center of said County road; thence along the center of said County Road N 7-00 W 75 feet to a point; thence N 21-45 W, along said road, 75 feet to the point of beginning and being the same conveyed to the Church in Deed Book 880, at page 23.
