WHEREAS I, F. H. Gillespie

am well and truly indebted to

in the full and just sum of One Hundred Ten Thousand and no/100ths (\$110,000.00) Dollars, in and by my certain promissory note in writing of even date herewith, due and payable ~~xxxxx~~ in equal monthly installments of principal and interest in the amount of \$1,453.71, commencing on the first day of February, 1971, and continuing thereafter until paid in full on or before January 1, 1981,

ALL that lot of land with the buildings and improvements thereon situate on the southwest side of Pelham Road (also known as State Road No. 492) near the City of Greenville, in Greenville County, South Carolina, and having, according to survey made by C. O. Riddle, in October, 1964, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southwest edge of Pelham Road at the northwest corner of property now or formerly of DeCamp and runs thence along said DeCamp line S. 3-41 W. 353.6 feet to an iron pin; thence S. 0-31 E. 904.8 feet to a point in center of Rocky Creek; thence along the center of Rocky Creek as the line, the traverse lines being as follows: N. 67-45 W. 177 feet, S. 89-20 W. 100 feet, S. 61-00 W. 100 feet to a point in center of said Creek; thence N. 5-18 E. 1264.1 feet to an iron pin on the southwest edge of Pelham Road; thence along Pelham Road S. 84-03 E. 95 feet to an iron pin; thence still along Pelham Road S. 86-48 E. 155 feet to the beginning corner and containing, according to said plat, 8.13 acres.
