NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the southern area of Donaldson Center, bounded on the west by other lands of Ralph Lee Construction Corp., on the north by the southern right-of-way of Engineer Street, on the east by the western right-of-way of Old Augusta Road, and on the south by other lands of Donaldson Center, and being more particularly described as follows:

BEGINNING at an iron pin at the intersection of the southern right-of-way line of Engineer Street and the western right-of-way of Old Augusta Road, said pin being located in the extreme northeastern corner of the herein described tract; thence from the beginning corner and along the western right-of-way of Old Augusta Road, S. 8-11 W. 152.6 feet to an iron pin; thence continuing along the western right-ofway of Old Augusta Road, S. 7-40 W. 119.6 feet to an iron pin; thence leaving the Old Augusta Road right-of-way and along a new line through the lands of Donaldson Center, N. 67-27 W. 230 feet to an iron pin, said pin being the common corner to other lands of Ralph Lee Construction Corp. and the herein described tract; thence along the lands of Ralph Lee Construction Corp., N. 17-26 E. 264.24 feet to an iron pin on the southern right-of-way of Engineer Street; thence leaving the lands of Ralph Lee Construction Corp. and along the southern right-of-way of Engineer Street, S. 67-31 E. 185 feet to the point of beginning, and containing 1.25 acres, more or less; and more fully identified by map attached as surveyed October 25, 1967, by Campbell and Clarkson, Surveyors, S.
