"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oaklawn Township, near Pelzer, lying and being on the Northern side of S. C. Highway, No. 8 and having the following metes and bounds, to-wit:

HEGINNING at an iron pin S. 83-03 E. 387 feet from an iron pin in the survature of the intersection of State Highway No. 8 and the Old Pelzer Road and running thence with the Northern side of said Highway No. 8, S. 83-03 E. 190 feet to an iron pin; thence N. 7-0 E. 203.5 feet to an iron pin; thence N. 83-03 W. 1190 feet to an iron pin; thence S. 7-0 W. 203.5 feet to an iron pin on the Northern side of S. C. Highway No. 8, the point of beginning. This being that same lot of land conveyed to me by deed of Mary Ellen Austin King by her deed of Even Date.

Together with all and singular rights, mambers, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
