"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, and being on the South side of Arlington Avenue (formerly Garlington Street), in Ward Five of the City of Greenville, and being designated as Lot No. 5 in Block B, as shown on plat of Pendleton Street Realty Association, recorded in the REC office for Greenville County in Plat Book A, page 122 and page 123; and having, the following metes and bounds, to-wit:

BEGINVING at an iron pin on the South side of Arlington Avenue 200 feet from the Southwest corner of Sunner Street and Arlington Avenue; thence along Arlington Avenue, N. 72-85 W. 50 feet to an iron pin, corner of Lot No. 6; thence with line of Lot No. 6, S. 15-15 W. 197 feet 8 inches to an iron pin; thence S. 72-35 E. 50 feet to an iron pin, corner of Lot No. 4; thence with line of Lot No. 4, N. 15-15 E. 196, 1 inch to beginning corner on Arlington Avenue.
