NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note or even date from Mortgagor to Universal C.I.T. Credit Company (hereafter "Mortgagee") in the above Total of Payments, and all future advances from Mortgagee to Mortgagor, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all improvements thereon situated in South Carolina, County of Greenville.

All that certain piece, parcel or lot of land situate, lying and being on the northeastern side of Glass (formerly Wright) Street, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 25 and a portion of Lot No. 24 as shown on a plat of the J. P. Goodwin property prepared by W. A. Hudson, recorded in the R.M.C. Office for Greenville County in Deed Book "NNN", at page 485, and having, according to a more recent plat prepared by J. Mac Richardson, dated September 9, 1959, entitled property of Roy Reeves, the following metes and bounds: BEGINNING at an iron pin on the northeastern side of Glass (formerly Wright) Street at the joint front corner of Lots Nos 25 and 26, and running thence with the line of Lot No. 26 N. 59-15 E. 193 feet to an iron pin on the westerly side of Church Street; thence with the westerly side of Church Street S. 21-20 E. 81 feet to an iron pin in the front line of Lot No. 24; thence a new line through Lot No. 24 S. 59-15 W. 193 feet to an iron pin on the northeastern side of Glass (formerly Wright) Street; thence with the northeastern side of Glass (formerly Wright) Street N. 21-20 W. 81 feet to the point of beginning.

Mortgagor also agrees to maintain insurance in such form and amount as may be satisfactory to the Mortgagee in Mortgagee's favor, and in default thereof Mortgagor may, but is not obligated to, effect said insurance in its own name.

Any amount which Mortgagee may expend to discharge any tax, lien, assessment, obligation, covenant, insurance premium, prior mortgage or any charge whatsoever in connection with the above described real estate shall be an additional lien secured by this mortgage with interest at the highest lawful rate if not prohibited by law, and may be enforced and collected in the same manner as the debt hereby secured.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagee against Mortgagor on the above described real estate.
