WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Eleven Thousand, Six Hundred and 00/100

DOLLARS (\$ 11,600.00), with interest thereon from date at the rate of Seven & Three-Quarters per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, on the Southern side of Burbank Court, shown and designated as Lot 216 on a Plat of Rockvale, Section 2, which Plat is recorded in the R.M.C. Office for Greenville County in Plat Book QQ, Page 109, and has, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Burbank Court, at the joint front corner of lots 216 and 217 and running thence with the joint line of said lots, S. 3-39 W., 236 ft. to a point in a creek approximately 8 ft. from an iron pin located on the joint line of lots 216 and 217; thence N. 86-21 W., 79.4 ft. to an iron pin; thence N. 4-39 E., 260 ft. to an iron pin on the Southern side of Burbank Court; thence along the side of said Burbank Court, S. 86-21 E., 15.9 ft. to an iron pin and with the circle shown on said Plat, the chord of which is S. 66-15 E., 63.5 ft. to an iron pin at the point of beginning.
