NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to Universal C.I.T. Credit Company (hereafter "Mortgagee") in the above Total of Payments and all future advances from Mortgagee to Mortgagor, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all improvements thereon situated in South Carolina, County of Greenville.

All That lot or parcel of land with all improvements thereon containing 11,000 Sq. feet, more or less, situate, lying and being in Greenville, Township, in the County of Greenville, State of South Carolina, near the southern limit of the City of Greenville, and having the following metes and bounds, viz:  
 Beginning at a stake 3X on east side of Church Street (now Mission St.) and running thence with said Street S. 36 1/4 E. 55 feet to a stake 3X; thence N. 53 1/2 E. 200 feet to a stake 3X; thence N. 36 1/4 W. 55 feet to a stake 3X; thence S. 53 1/2 W. 200 feet to the beginning corner. The same being Lot No. 20 on a plat made by J. N. Southern for O. P. Mills, and joining on said plat Lot Nos, 21, 19 and 42 with said plat being recorded in the R. M. C. Office for Greenville County in Plat Book "C", at page 193.

TO HAVE AND TO HOLD all and singular the premises described above unto the said Mortgagee, its successors and assigns forever.

If the Mortgagor shall fully pay according to its terms the indebtedness hereby secured then this mortgage shall become null and void.

Mortgagor agrees to pay all taxes, assessments and charges against the above-described premises.

Mortgagor also agrees to maintain insurance in such form and amount as may be satisfactory to the Mortgagee in Mortgagee's favor, and in default thereof Mortgagee may, but is not obligated to, effect said insurance in its own name.

Any amount which Mortgagee may expend to discharge any tax, lien, assessment, obligation, covenant, insurance premium, prior mortgage or any charge whatsoever in connection with the above described real estate shall be an additional lien secured by this mortgage with interest at the highest lawful rate if not prohibited by law, and may be enforced and collected in the same manner as the debt hereby secured.

All obligations of Mortgagor to Mortgagee shall become due, at the option of Mortgagee, without notice or demand, upon any default.

Mortgagor agrees in case of foreclosure of this mortgage to pay a reasonable attorney's fee as determined by the court in which suit is filed and any court costs which shall be secured by this mortgage and included in judgment of foreclosure.

This mortgage shall extend, consolidate and renew any existing mortgage held by Mortgagee against Mortgagor on the above described real estate.
