(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto SALUDA VALLEY FEDERAL SAVINGS AND LOAN ASSOCIATION OF Williamston, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of NINE THOUSAND FIVE HUNDRED AND NO/100 -----

DOLLARS (\$ 9,500.00 ), with interest thereon from date at the rate of eight---(8%) per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, State of South Carolina, known and designated as Lot No. 12 and the westernmost portion of Lot No. 11 as shown on a plat of the property of R.L. Hallman, Jr. and M.L. Propps, recorded in the RMC Office for Greenville County in Plat Book KK at page 94, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the northern side of Piedmont Avenue Extension at a point common with Lots No. 12 and 13 of said plat and running N. 13-17 E. 143.1 feet; thence S. 79-43 E. 160.1 feet; thence S. 13-17 W. 150.3 feet; thence N. 76-43 W. 160 feet to the point of beginning.
