ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, to wit: ALL THAT LOT OF LAND WITH THE ____, to wit: ALL THAT LOT OF LAND WITH THE BUILDINGS AND IMPROVEMENTS THEREON, SITUATE ON THE WEST SIDE OF DONNON ROAD NEAR THE CITY OF GREENVILLE, IN GREENVILLE COUNTY, S. C., BEING SHOWN AS LOT NO. 2 ON PLAT OF PROPERTY OF JOHN LUDE VAUGHN, RECORDED IN THE RMC OFFICE FOR GREENVILLE COUNTY, S. BEGINNING AT AN IRON PIN ON THE WEST SIDE OF DONNON ROAD AT A POINT 304.4 FEET SOUTH OF THE WESTERLY CORNER OF THE INTERSECTION OF DONNON ROAD AND WAREHOUSE COURT, SAID PIN BEING AT THE JOINT FRONT CORNER OF LOTS 1 AND 2, AND RUNS THENCE ALONG JOINT LINE OF SAID LOTS, N. 88-10 W., 200 FEET TO AN IRON PIN IN LINE OF LOTNO. 4; THENCE ALONG THE LINE OF LOT No. 4, S. 1-55 W. 85 FEET TO AN IRON PIN; THENCE ALONG THE LINE OF LOTS 2 AND 3, S. 88-10 E., 200 FEET TO AN IRON PIN ON WEST SIDE OF DONNON ROAD; THENCE ALONG THE WEST SIDE OF DONNON ROAD, N. 1-55 E., 85 FEET TO THE BEGINNING.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgage, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise

(2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums therefor when due; and that it does hereby assign to the Mortgagee the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgagee, to the extent of the balance owing on the Mortgagee debt, whether due or not.
