WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Connecticut Drive, being shown as Lot No. 4 on plat of Merrifield Park, Section II, recorded in Plat Book WWW, Pages 50 and 51 in the RMC Office for Greenville County, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Eastern side of Connecticut Drive, at the joint front corner of Lots 4 and 5, running thence down the joint line of said lots, S. 55-51 E. 165.1 feet to an iron pin in the center of a Duke Power Company right-of-way; thence down said right-of-way, N. 32-27 E. 135 feet to an iron pin at the joint rear corner of Lots 3 and 4; running thence down the joint line of said lots, N. 57-33 W. 165 feet to an iron pin on the Southern side of Connecticut Drive; running thence with the Southern side of Connecticut Drive, S. 32-27 W. 130 feet to the point of beginning.
