NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, about seven miles North of Greer, located on the Northeastern side of the Jordan Road, containing 1 acre, more or less, as shown on survey for K. V. Sloan, dated August 18, 1970, by W. N. Willis, Engineer, said survey to be recorded herewith, and having, according to said survey, the following metes and bounds, to-wit:

BEGINNING at a nail in the center of the Jordan Road (iron pin back at 33 feet), and running thence N. 51-30 E. 210 feet to an iron pin; thence S. 38-30 E. 210 feet to an iron pin; thence S. 51-30 W. 210 to a nail in center of Jordan Road (iron pin back at 33 feet); thence along and with the Jordan Road, N. 38-30 W. 210 feet to the point of beginning.
