Gerald W. Orndorff & Patty H. Orndorff--(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-six Thousand Four Hundred Fifty and No/100 ------DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the northern and western sides of Del Norte Road and known and designated as Lot No. 92 of a subdivision known as an addition to Section 4, Del Norte Estates, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 4N at Page 10 and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Del Norte Road at the joint front corner of Lots Nos. 92 and 93 and running thence with the joint line of said lots N. 4-35 E., 140 feet to an iron pin in the line of Lot No. 107; running thence with the joint line of that lot S. 84-35 E., 98.5 feet to an iron pin on the western side of Del Norte Road; running thence with the western side of said road which road is curved the following courses and distances, to-wit: S. 23-25 E., 23.7 feet; S. 0-41 W., 25.5 feet; S. 10-20 W., 21 feet; S. 22-18 W., 22.1 feet; S. 36-07 W., 23.6 feet; S. 50-0 W., 20.75 feet; S. 66 -57 W., 26.9 feet; S. 87-16 W., 27.45 feet; N. 84-35 W., 24 feet to an iron pin, point of beginning.
