"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina being in the Piedmont Manufacturing Company Village, in or near the Town of Piedmont, and being more particularly described as Lot No. 49, section 4, as shown on a plat entitled "Property of Piedmont Manufacturing Company, Greenville County, "made by Dalton and Neves, February, 1950; sections 3 and 4 of said plat are recorded in the R. M. C. Office for Greenville County in Plat Book Y, at pages 2 - 5, inclusive and pages 6 - 9, inclusive, respectively.
