"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Saluda Township, on the North Saluda River, known as part of the Hightower land and bounded by lands of Goodwin, Cox, Trammell and containing 118 acres, more or less. Said tract of land, according to a more recent survey of the property of Wallace Hawkins made by J. C. Hill, Engr., dated July 6, 1964, and recorded in the RMC Office for Greenville County in Plat Book "HHH", at page 53, contains 146.3 acres, more

ALSO: ALL that piece, parcel or tract of land in the County of Greenville, State of South Carolina, in Saluda Township, containing 17 acres, more or less, and being a portion of the property conveyed to Bruce R. Holt and Annie Mae Holt in Deed Book 272, at page 254, and being shown on the County Block Book at Sheet 522.2-1-10.1.
