To All Whom These Presents May Concern:

We, M. Stansel Kemp and Shirley Y. Kemp SEND GREETING:

WHEREAS, we the said M. Stansel Kemp and Shirley Y. Kemp
in and by our certain promissory note in writing of even date with these Presents, are well
and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of
Two Thousand and No/100 - - - - - (\$ 2,000.00) Dollars,
with interest from the date hereof at the rate of eight per cent (8 %) per annum, unpaid interest to
bear interest at the same rate, to be repaid in installments of

Thirty One and 18/100 - - - - - (\$ 31.18) Dollars
due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest
and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments
to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any,
incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder
shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of
said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at
the option of the holder become immediately due and payable, and said note further providing for a reasonable

KNOW ALL MEN BY THESE PRESENTS, That we the said M. Stansel Kemp &
Shirley Y. Kemp, in consideration of the said debt and sums of money
aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION,
Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00)
Dollars to us the said mortgagor.s in hand well and truly paid by the said mortgagee, at and
before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained,
sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND
LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter
constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal
Township, located on the Southern side of the Langley Road and being shown on plat
made for Marion S. Kemp by Terry T. Dill, surveyor, dated August 23, 1971, and
having the following metes and bounds to wit:

Beginning in the center of said road at corner of George V. Mappin and runs
thence with this line, S. 21-13 E., 285 feet to iron pin; thence along property of
W. B. McCarter, S. 25-25 W., 180.5 feet to iron pin at corner of Claude M. Styles;
thence with Styles, N. 24-00 W., 404.7 feet to the center of said road; thence
along the center of said road, N. 68-32 E., 149.5 feet to the beginning corner and
containing 1.10 acres more or less.

Also, that certain lot, parcel or tract of land, situated, lying and being
in the State and County aforesaid. Located on the Northern side of Styles Road and
being shown and designated as all of Lot Number Two (2) on plat of property made
for Josephine Youngblood, by W. P. Morrow, June 15, 1954 and recorded in plat book
FF page 195, Greenville County R. M. C. Office, and having the following metes and
bounds, to wit:

Beginning at an iron pin on the Northern side of said road at the Joint
front corner of lots 2 and 3 and running thence N. 61-20 E., 100 feet along said road
to an iron pin at the joint front corner of lots 1 and 2; thence N. 28-18 W., 248 feet
along line of lot No. 1 and driveway to iron pin, joint rear corner of said lots;
thence S. 60-50 W., 100 feet to the joint rear corner of lots 2 and 3; thence S.
28-18 E., 217 feet along the line of lot No. 3 to the beginning corner. Containing
