W. Brown Estate by Woodward Engineering Co., February 1957, and recarded in the R.M.C. Office for Greenville County in plat Book OO, Page 320, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on a county road leading to Staunton Bridge Road at the corner of Property formerly deeded to E. W. Brown, Jr., running thence N. 23-48 W. 100 feet to a point, thence S. 84-24 W. to a point; thence S. 6 E. 100 feet to the center of said county road; thence up the center of said road N. 84-24 W. 277 feet to the point of beginning.

ALSO, BEGINNING at the iron pin 100 feet Southwest of a county road leading to Staunton Bridge Road; thence S. 23-48 W. 410.8 feet to a point; thence S. 68-57 W. 125 feet to a point; thence N. 6 W. 353.3 feet to a point; thence N. 84-24 W. to the point of beginning.
