PARTIAL RELEASE OF LIEN

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of one dollar and other considerations, receipt whereof is hereby acknowledged, The Federal Land Bank of Columbia, the owner and holder of the security instrument hereinafter referred to and of the note(s) thereby secured does, subject to the conditions hereinafter stated, hereby release from the lien of that certain security instrument from Charles C. Mezey and Olga A. Mezey-

to The Federal Land Bank of Columbia, dated the 5th day of May, 1970, and recorded in the public records of Greenville County, State of South Carolina in Mortgage Book 1156, at page 557, the following described property, to-wit:

ALL that piece, parcel or lot of land, lying and being in Glassy Mountain Township, Greenville County, State of South Carolina, containing Twenty Six and Fifteen One-Hundredths (26.15) acres, more or less, being bounded on the North by Robert L. & Catherine W. Adams; on the East by other lands of Charles C. & Olga A. Mezey; on the South by R. C. Durham; and on the West by Archie Durham. This being more particularly described on a plat surveyed by E. H. Gibbs, Reg.L.S. #1003 and dated October 12, 1966.

PROVIDED, HOWEVER, that the security of The Federal Land Bank of Columbia as described in the aforesaid security instrument shall, in all respects, except as to the premises hereinbefore described, be preserved and protected and that the lien of said security instrument, except as hereby released and discharged, shall remain in full force and effect and the terms, conditions and covenants thereof and of the note(s) thereby secured, shall remain unchanged.
