(hereinafter referred to as Mortgagor) SEND(S) GREETING:

(\$ 41,850.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northerly side of Runnymede Road, near the City of Greenville, being known and designated as Lot No. 87 on plat of Foxcroft, Section I, as recorded in the RMC Office for Greenville County in Plat Book 4-F, Pages 2, 3 and 4, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northerly side of Runnymede Road, said pin being the joint front corner of Lots Nos. 86 and 87, running thence with the common line of said Lots N. 4-30 W. 160 feet to an iron pin to joint rear corner of Lots Nos. 86 and 87, thence S. 86-44 W. 170 feet to an iron pin, the joint rear corner of Lots Nos. 87 and 88; thence with the corner line of said lots S. 25-26 E. 189.5 feet to an iron pin on the northerly side of Runnymede Road; thence with the northern side of Runnymede Road N. 72-32 E. 47.2 feet to an iron pin; thence N. 82-01 E. 47.2 feet to an iron pin; thence N. 86-44 E. 9.4 feet to an iron pin; the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgager promises to pay to the mortgages for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgages may advance it for the mortgager's amount and collect it as part of the debt secured by the mortgage.

The mortgagers agree that after the empiration of ten years from the date hereof, the mortgages may at is option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgager agrees to pay to the mortgages as premium for such insurance one half of 1% of the principal balance then existing.
