(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **EIGHT THOUSAND AND NO/100THS**

DOLLARS (\$ **8,000.00**), with interest thereon from date at the rate of **EIGHT (8%)** per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at Marietta, S. C., on the eastern side of Duff Road approximately 400 feet South of Pearl Avenue, and being a portion of the E. Sherwood Guest Property and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Duff Road at the corner of Whitfield and running thence N 65 E 138 feet to an iron pin; thence S 26 E 175.5 feet to an iron pin; thence S 60 W 137.5 feet to an iron pin on the eastern side of said Road; thence with Duff Road, N 26 W 184 feet to the point of beginning and being the same conveyed to me in Deed Book 562, at page 513.

ALSO: ALL of that strip of land adjoining the above property, being one-half of Edna Street, which has never been opened, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of Ford and Whitfield at the rear of the above lot, and running thence N 60 E 15 feet to an iron pin; thence N 26 W 175 feet to an iron pin; thence S 65 W 15 feet to an iron pin; thence S 26 E 175.5 feet to the point of beginning and being the same conveyed to me in Deed Book 878, at page 577.
