

MORTGAGE OF REAL ESTATE

COUNTY OF GREENVILLE

To All Whom These Presents May Concern:

P & W CONSTRUCTORS, INC.

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

TWENTY-FOUR THOUSAND AND NO/100 ----- (\$24,000.00)

Dollars, as évidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being on the westerly side of S. C. Highway #14, and being the southerly 1.49 acres of a 15.71 acre tract conveyed to the Grantor herein by J. P. Dempsey, a plat of said 15.71 acres being recorded in Plat Book UUU, page 159, made by Campbell & Clarkson; and having according to a more recent survey made by Enwright Associates, dated October 21, 1970, the following metes and bounds, to-wit:

BEGINNING at a nail and bottle top in the center of S. C. Highway #14, joint corner of property now or formerly of J. P. Dempsey; and running thence along the Dempsey line North 67-19 W. 211.8 feet to an iron pin; thence N. 1-15 W. 250 feet to an iron pin; thence S. 66-40 E. 363.58 feet to a nail and bottle top in the center of said S. C. Highway #14; thence along the center of said highway S. 35-20 W. 230 feet to a nail and bottle top to the point of beginning.
