Ballentine and running thence with the line of property of the grantor and grantee herein S 70-22 E 352.45 feet to an iron pin; thence N 16-40 E 45 feet to a point; thence with a new line N 70 22 W 352.45 feet to a point on the Eastern side of Raven Road; thence with the Eastern side of Raven Road, S 16-40 W 45 feet to the point of BEGINNING.
