"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, being described according to a plat of the Property of Walter D. Tate surveyed September 14, 1972, by Terry T. Dill, said plat being of record in the R.M.C. Office for Greenville County in Plat Book 40 at Page II and having, according to said plat, the following metès and bounds, to wit:

BEGINNING at a bolt in the center of a county road and running thence to an iron pin on the western side of said road; thence S. 71-37 W. 652.5 feet to an iron pin; thence N. 9-47 W. 200 feet to an iron pin; thence N. 72-20 E. 693 feet to an iron pin on the western side of said county road; thence continuing in a straight line to a bolt in the center of said county road; thence along the center of said county road S. 2-05 W. 200 feet to the point of beginning.
