"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about three and three-quarters of a mile from the city of Greenville on the Old Anderson Road, containing twenty (20) acres, more or less, and described as follows:

Beginning at a point in the Old Anderson Road, corner of Maude V.
