All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Sherborne Drive, being shown and designated as Lot No. 488, on plat of Addition to Section III, Del Norte Estates, recorded in the RMC Office for Greenville County, S. C., in Plat Book "4 R", at Page 16, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at anxiron pin on the westerly side of Sherborne Drive at joint front corner of Lots Nos. 488 and 489, and running thence with common line of said lots to an iron pin, S. 28-33 W. 135.0 feet to an iron pin, joint rear corner of said lots; thence along rear line of Lot No. 488, N. 61-27 W. 95.0 feet to an iron pin, joint rear corner of Lots Nos. 488 and 487; thence along common line of Lots Nos. 488 and 487, N. 28-33 E. 135.0 feet to an iron pin on the westerly side of Sherborne Drive, joint front corner of said lots; thence along the westerly side of Sherborne Drive, S. 61-27 E. 95.0 feet to an iron pin, the point of BEGINNING.
