All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeasterly side of East Indian Circle, near the City of Greenville, S. C., being known and designated as Lot No. 9 on plat entitled "Final Plat, Seven Oaks," as recorded in the RMC Office for Greenville County, S. O., in Plat Book 4R, page 6, and having, according to said plat; the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of East Indian Circle, said pin being the joint from corner of Lots 8 and 9, and running thence with the common line of said lots N 58-57 E 175 feet to an iron pin the joint rear corner of Lots 8 and 9; thence N 8-03 W 80 feet to an iron pin; thence N 39-22 W 123.9 feet to an iron pin the joint rear corner of Lots 9 and 11; thence S 26-57 W 244.4 feet to an iron pin on the northeasterly side of East Indian Circle; thence with the northeasterly side of East Indian Circle on a curve the chord of which is S 47-03 E 68.9 feet to an iron pin, the point of beginning.
