shall remain in full force and effect.

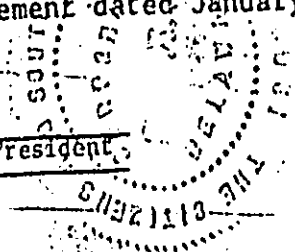
