All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, containing 783.17 acres, more or less, situate on the Westerly side of Old Piedmont Highway, near the City of Greenville, as shown on plat entitled "Property of W. C. Cleveland Estate", prepared by Piedmont Engineers & Architects, dated April 1, 1966, and recorded in the RMC office for Greenville County, S.
