That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Seventh Street in Section No. 4 of Judson Mills Village, near the City of Greenville, being known and designated as Lot No. 25 as shown on a plat of Section No. 4 of Judson Mills Village, made by Dalton & Neves, Engineers, January 1941, which plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "K" at pages 75 and 76, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Seventh Street, joint front corner of Lots Nos. 25 and 26, said pin also being 79.9 feet west from the southwest corner of the intersection of Seventh Street and Hawkins Avenue and running thence with the line of Lot No. 26, S. 1-42 E. 119.4 to an iron pin; thence with the rear line of Lot No. 12, S. 88-03 W. 61 feet to an iron pin; thence with the line of Lot No. 24 N. 1-42 W. 119.5 feet to an iron pin on the south side of Seventh Street; thence with the south side of Seventh Street; N. 8-10 E. 81 feet to the beginning corner.
