"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, at the southeastern corner of the intersection of Laurens Road and Coolidge Avenue, and being known and designated on a Plat of Glenn Grove Park, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "F" at page 233 as Lot 5, and having, according to said Plat, the following metes and bounds:
