STATE OF SOUTH CAROLINA COUNTY OF GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN: WILLIAM C. MOOSE AND DORIS S. MOOSE

(hereinaster referred to as Mortgagor) SEND(S) GREETING:

DOLLARS (\$19,350.00-----), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, May 1, 1998.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the southerly side of Forestdale Drive, being shown and designated as Lot No. 66, on plat of Forestdale Heights, recorded in the RMC Office for Greenville County, S. C., in Plat Book "KK", at Page 199, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin located on the southerly side of Forestdale Drive 313.7 feet from the intersection of Forestdale Drive and Edwards Road, being the joint front corner of Lots Nos. 66 and 67, and running thence S. 85-29 E. 70 feet along the southerly side of Forestdale Drive to an iron pin, being the joint front corner of Lots Nos. 65 and 66; thence running S. 04-31 W. 199.03 feet along the side line of Lot No. 65 to an iron pin, being the joint rear corner of Lots Nos. 65 and 66; thence running N. 85-45 W. 70 feet to an iron pin, being the joint rear corner of Lots Nos. 66 and 67; thence running N. 04-31 E. 199.4 feet along the side line of Lot No. 67 to an iron pin located on the southern side of Forestdale Drive, being the joint front corner of Lots Nos. 66 and 67, the point of BEGINNING.
