SEND GREETINGS:

WHEREAS, I, WE THE SAID Sem S. Brubaker and Gloria Brubaker,  
HEREINAFTER CALLED MORTGAGOR, IN AND BY MY, OUR CERTAIN NOTE OR OBLIGATION BEARING  
EVEN DATE HERewith, STAND INDEBTED, FIRMLY HELD AND BOUND UNTO THE CITIZENS AND  
SOUTHERN NATIONAL BANK OF SOUTH CAROLINA, Greenville, S. C., HEREINAFTER  
CALLED MORTGAGEE, THE SUM OF Nine Thousand, Seven Hundred Fifty seven  
and 80/100---  
DOLLARS (\$9757.80 ), REPRESENTING \$7000.00 OF PRINCIPAL  
AND \$2757.80 OF INTEREST, BEING DUE AND PAYABLE IN EQUAL MONTHLY INSTALLMENTS  
OF \$162.63, COMMENCING ON THE 15th DAY OF June, 1973,  
AND ON THE SAME DATE OF EACH SUCCESSIVE MONTH THEREAFTER.

Said note provides that past due principal and/or interest shall bear interest at the rate of seven (7%) per  
cent per annum as reference being had to said note will more fully appear; default in any payment of either principal  
or interest to render the whole debt due at the option of the Mortgagee or holder hereof. Forbearance to exercise  
this right with respect to any failure or breach of the maker shall not constitute a waiver of the right as to any sub-

and 209 and having according to said plat the following metes and bounds,

BEGINNING at an iron pin on southeastern side of Sevier Street, at joint front  
corner of Lots 59 and 92, running thence along line of Lot No. 59 S. 70-  
08 E. 200 feet to ~~xxx~~ iron pin on northwestern side a 45 foot unnamed street  
thence along the northwestern side of said 45 foot street N. 29-02 E. 76 feet  
to iron pin at joint rear corner of Lots No. 58 and 92; thence with line of
