MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, Mac Arthur McKinney, of the County and the State aforesaid,

(hereinafter referred to as Mortgagor) is well and truly indebted unto Delta Finance and Loan Company, a Corporation,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are

in Sixty (60) monthly installments of Sixty-four (\$54.00) Dollars each month, commencing July 4, 1973, and on the fourth day of each and every month therafter, until paid in full

with interest thereon from date at the rate of 8g per centum per annum, to be paid: after maturity

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

All that lor of land with improvements, lying on the Southern side of Alpha Drive in Gantt Township, Greenville County, South Carolinabeing shown anddesignated as Lot No. 97 on a plat of KENNEDY PARK, made by Piedmont Engineers and Architects, dated September 28, 1964, revised on January 28, 1966, and recorded in the RMS office for Greenville County, S.C., in Plat book JJJ, page179, said lot being 75 feet wide and 133 feet deep.

The above described property is hereby conveyed subject to rights of way and easments show on the aforementioned recorded plat and applicable to Kennedy Park and to restrictive convenants recorded in the RFC office for Greenville County, S.C., in Deed book 773, page 527.

As a part of the consideration for this deed, the Grantees assume and agree to pay in full the indebtness due on a note and mortgage convering the abovedescribed property in favor of Anderson Savings and Loan Association of Anderson, S.C. recorded in the RMC office for said County and State in Mortgage book1055, page 385, which has a present balance due in the sum of \$10,100.00.

The Grantees agree to pay 1967 Greenville County property taxes.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the partles hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Merigagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumbe, the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Morigagor further covenants to warrant and forever defend all and singular the said premises unto the Morigagor forever, from and against the Morigagor and all persons whomspever fawfully claiming the same or any part thereof.
