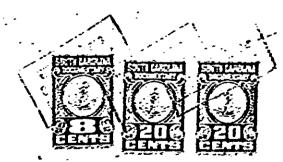

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced bereafter, at the option of the Mortgagee, for the payment of taxes, issurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein.
