DOLLARS (\$ 25,500.00) with interest thereon from date at the rate of **eight (8%)**

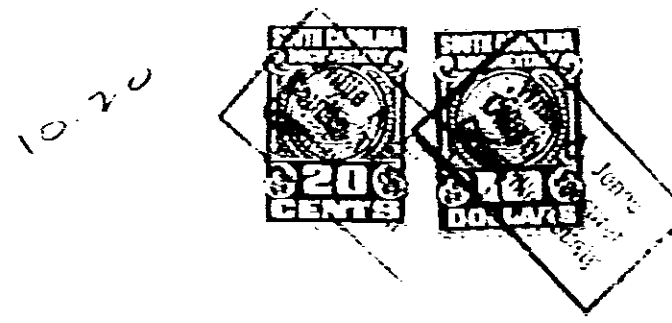
per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of the e presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville on the southwestern side of Brookwood Drive in Chicks Springs Township near the City Limits of Greer, being shown and designated as Lot No. 17 on a plat of Brookwood made by B. B. Waters, Jr., dated October 14, 1968 recorded in the RMC Office for Greenville County, South Carolina in Plat Book QQ, page 21 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Brookwood Drive at the joint front corner of Lots Nos. 16 and 17 and thence with the common line of said lots, S. 38-24 W. 180 feet to an iron pin; thence with the line of property now or formerly belonging to the J. V. Smith Estate N. 51-36 W. 120 feet to an iron pin; thence with the southeastern most side of a twenty foot strip (said twenty foot strip being adjacent to the southeastern most side of Lot No. 18), N. 38-24 E. 180 feet to an iron pin on the southwestern side of Brookwood Drive; thence with the southwestern side of Brookwood Drive, S. 51-36 E. 120 feet to an iron pin, the point of beginning.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
