"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville on the southwestern side of Brookwood Drive in Chicks Springs Township near the City Limits of Greer, being shown and designated as Lot No. 17 on a plat of Brookwood made by B. B. Waters, Jr., dated October 14, 1968 recorded in the RMC Office for Greenville County, South Carolina in Plat Book QQ, page 21 and having according to said plat, the following metes and bounds, to-wit:
