WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Twenty Seven Thousand Two Hundred and No/100 ----- DOLLARS

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as lot no. 53 on a plat entitled Del Norte Estates, recorded in Plat Book WW at Pages 32 and 33 in the R.M.C. Office for Greenville County. According to said plat, the property is more fully described as follows:

BEGINNING at an iron pin on Great Glen Court at the joint front corners of lots nos. 53 and 54 and running thence along the joint line of said lots N. 57-03 E. 140.0 feet to an iron pin; thence N. 31-55 W. 100 feet to an iron pin at the joint rear corner of lots nos. 52 & 53; thence along the joint line of said lots S. 57-02 W. 135.0 feet to an iron pin on Great Glen Court; thence S. 29-10 E. 100.0 feet to an iron pin, the point of beginning.
