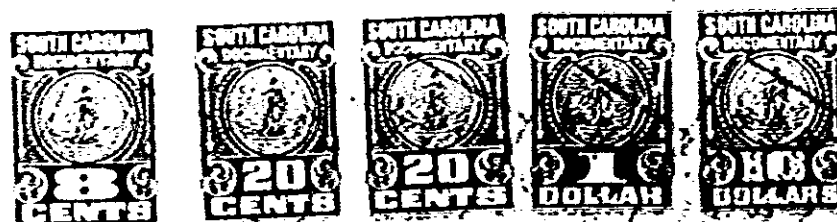

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as lot no. 53 on a plat of Eastgate Village made by Piedmont Engineers and Architects dated May 15, 1973, and recorded in the RMC Office for Greenville County in Plat Book \_\_\_\_\_ at Page \_\_\_\_\_. According to said plat, the property is more fully described as follows:

BEGINNING at an iron pin on Pritchard Lane at the joint front corner of lots nos. 53 and 54; thence with the joint line of said lots N. 61-00 W. 75.0 feet to an iron pin on line of area designated as "open greenway"; thence with line of "open greenway" S. 29-30 W. 104.2 feet to an iron pin; thence continuing with said "open greenway" S. 24-28 E. 40.0 feet to an iron pin at the front corner of lot no. 52; thence with line of lot no. 52, N. 73-00 E. 100.0 feet to an iron pin on the turnaround of Pritchard Lane; thence with the curve of said turnaround, N. 12-56 W. 35.0 feet to an iron pin; thence continuing with said turnaround N. 25-06 E. 30.0 feet to an iron pin, the point of beginning.
