ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown as Lot No. 49 on plat of Sec. I, Oak Crest, as recorded in the RMC Office for Greenville County, S.C., in Plat Book GG, at Pages 110 - 111, and having, according to said plat, the following courses and distances, to-wit: BEGINNING at an iron pin on the eastern side of Templewood Drive, joint front corner of Lots Nos. 50 and 49, and running thence with said Templewood Drive, N. 60-02 E. 75 feet to an iron pin, joint front corner of Lots Nos. 49 and 48; thence with the common line of said lots, S. 29-58 E. 150 feet to an iron pin; thence, S. 60-02 W. 75 feet to an iron pin, joint rear corner of Lots Nos. 49 and 50; thence with the common line of said lots, N. 29-58 W. 150 feet to an iron pin, the point of beginning.
