ALL that piece, parcel or lot of land situate, lying and being on the eastern side of Rockbridge Road near the Town of Mauldin, in the County of Greenville, State of South Carolina and known and designated as Lot No. 64, Section 2 of a subdivision known as Forrester Woods, plat of which is recorded in the R.M.C.
