- (8) That the covenents herein contained shall bind, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors and assigns, of the parties herets. Whenever used, the singular shell included the plural, the pivral the singular, and the use of any gender shall be applicable to all genders.
