NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as the greater portion of Lot 44 on a plat of McSwain Gardens recorded in the RMC Office for Greenville County in plat book GG at page 75, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Linwood Avenue, joint front corner of Lots 44 & 45; thence with the joint line of said lots S. 53-12 E. 164.9 feet to an iron pin the joint rear corner of Lots 44 & 31; thence with the rear line of Lot No. 31 N. 78-23 E. 83.4 feet to an iron pin, the joint rear corner of Lots 44 & 43; thence with a new line through lot No. 44, N. 11-56 W. 155.9 feet to an iron pin on the south side of Linwood Avenue, said iron pin being 5.3 feet west of the joint front corner of Lots 44 & 43; thence along the south side of said Avenue S. 80-00 W. 82.5 feet to an iron pin; thence continuing S. 65-07 W. 83.2 feet to an iron pin; thence continuing with the south side of said Avenue S. 49-53 W. 32.3 feet to the point of beginning.
