- (1) That this mortgage snall secure the Mortgagee for such fur ther sums as may be advanced hereafter, at the option of the Mo gagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants here. - (1) That it will keep all improvements now existing or hereafter created in good repair, and, in the case of a construction lean, that it will construct on until completion without interruption, and should it fall to do so, the Mortgages may, at its option, enter upon said premises, make whatever repairs are necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
- (4) That it will pay, when due, all taxes, public assessments, and other governmental or employed charges, fines or other impositions against the morigaged premises. That it will comply with all coremmental and municipal laws and regulations affecting the mortgaged Ŷ · ·

- (6) That it there is a default in any of the terms, conditions, or covanants of this mortgage, or of the note secured hereby, then, at the option of the horigagee, all sums then owing by the Moragagor to the Mortgagee shall become immediately due and payable, and this mortgage may be foreclosed. Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgagee become a party of any suit involving this Mortgage or the title to the premises described herein, or should the debt secured hereby or any part thereof be placed in the hands of any attorney at law for collection by suit or otherwise, all costs and expenses incurred by the Mortgagce, and a reasonable attorney's fee, shall thereupon become due and payable immediately or on demand, at the option of the Mortgagee, as a part of the debt secured hereby, and may be recovered and collected hereunder.
- (7) That the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgage or in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of the mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void; etherwise to remain in full force and virtue.
