MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

BRUCE W. PORTUS AND REBECCA D. PORTUS

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly inalebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of

THIRTY-FIVE THOUSAND TWO HUNDRED AND NO/100 (\$ 35,200.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith which note a provision for escalation of interest rate (paragraphs 9 and 10 of this mortzing provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

Two Hundred Seventy and 66/100 15 270.66) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on impaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date, and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereinder shall be past due and unpaid for a period of thaty days, or if there shall be any fulne to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereinder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings, and

WHEREAS, the Mortgagor may hereafter become in lebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes insurance premiums, repairs, or for any other purpose.

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to seeme the payment thereof and any further sums which may be advanced by the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$300) to the Mortgagor in hand well and truly poid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns, the following described real estate.

All that certain piece, parcel, or lot of had, with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Eliwood

Drive, being shown and designated as Lot No. 56 on plat of Edwards Forest Subdivision, Section IV, as shown on plat entitled "Property of Dorothy Edwards Cunningham", dated December, 1965 and recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book JJJ, at Page 82, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of Elmwood Drive, at the joint front corner of Lots 56 and 57, and running thence along the joint line of said Lots 56 and 57, S. 40-03 E. 180.5 feet to an iron pin; running thence S. 49-57 W. 100.4 feet to an iron pin at the joint rear corner of Lots 55 and 56; running thence along the joint line of said Lots 55 and 56, N. 40-03 W. 183.2 feet to an iron pin on the southeastern side of Elmwood Drive; running thence along the southeastern side of Elmwood Drive, N. 49-57 E. 100 feet to the beginning corner.
