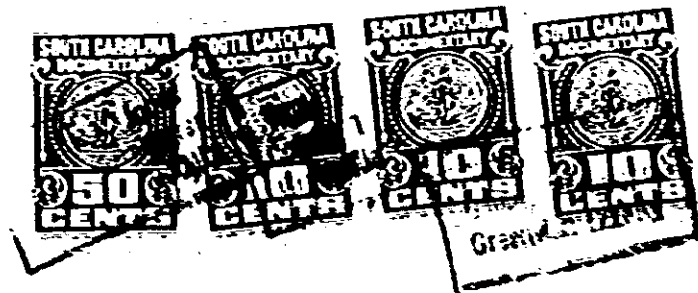

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Seabrook Court, being shown as Lot No. 1 on plat of Section E, Gower Estates, made by R. K. Campbell and Webb Surveying & Mapping Co., dated October, 1964, recorded in the RMC Office for Greenville County in Plat Book BBB at page 71, and having according to said plat the following metes and bounds:

BEGINNING at a point on the southern corner of Lots 1 and 2 and running thence along Lot 2, N. 27-18 W. 330.3 feet to an iron pin; thence S. 24-52 W. 184.5 feet to a point in the center of a branch; thence along the center of said branch, the traverse lines being as follows: S. 47-22 W. 210 feet and S. 10-22 W. 200.4 feet to a point in the center of said branch; thence N. 62-56 E. 470 feet to the beginning corner.
