"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 56 on a plat of Pelham Estates as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book PPP, at Pages 28 and 29, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at an iron pin on the northeastern side of Jamestown Drive, which iron pin is 186.5 feet from the intersection of Jamestown Drive and Hudson Road, and running thence, N. 45-59 E. 163 feet to an iron pin; thence, S. 41-11 E. 217.6 feet to an iron pin on the northwestern side of Hudson Road; thence running with said road, S. 54-57 W. 129.1 feet to an iron pin at the intersection of Hudson Road and Jamestown Drive; thence with said intersection, N. 84-32 W. 38 feet to an iron pin on Jamestown Drive; thence with Jamestown Drive, N. 44-01 W. 186.5 feet to an iron pin, the point of beginning.
