All that Piece, parcel or lot of land together with all building and improvements situate lying and being on the Northern Side of Eleventh Street near the City of Greenville in Greenville County, S.C. being shown and designated as Lot #69 on map of Section No. 5B of Judson Mill Village made by Dalton & Neves Engineers dated February 1940 recorded in the REC office for Greenville County, S.C. in Plat Book K at Pages 33 and 34, reference to which is hereby carved

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
